



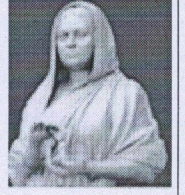

1. Hosted should have Managed live webcast service. Technical person on site to manage the Event in Advance, Viewer Support for laptop/PC/Smart Phone/Table, webpage design, Viewer static report recording playback for 60 days.
2. Video, Audio feed in composite with cables, Table Space, Power Supply, Internet connectivity (upload speed) of 2 Mbps (1:1), will be provided by the University.
3. Bill should be submitted only on completion of the work.
4. The shooting done by the service provider for the live webcasting Input will be provided by the University. It will be mandatory that Data (Video, Audio) should be casted on your own server and URL should be given one day before the Convocation Ceremony.
5. Internet connectivity will be provided by the University for the live Webcasting. The material required for the live Webcasting such as hardware, Software, CAT 6 Cable should be arranged by the service provider.(Bidder)
6. The responsibility of material required for the Live Webcasting will be of Service Provider and to give the Mock Test before the ceremony will be Compulsory.
7. Live webcasting should support any browser.
