NOTICE OF ELECTION OF CHAIRMAN OF BOARD OF STUDIES

Election of <u>CHAIRMAN</u> of the BOARD OF STUDIES from amongst the members of Boards of Studies under Section 40 (2) (d) (i) of the Maharashtra Public Universities Act, 2016.

In exercise of the powers conferred upon me under Sub-Section 6(d) of the Section 14 of the Maharashtra Public Universities Act, 2016, it is hereby notified for the information of all the members of BOARD OF STUDIES, the Election of Chairman of the Board of Studies will be held on Wednesday, 08th March, 2023 in the meeting of the Board of Studies under Section 40 (2) (d) (i) of the Maharashtra Public Universities Act, 2016. Following are the eligibility conditions for the post of Chairman as mentioned in the Govt. of Maharashtra Gazette dated 29th April, 2017:

- 1) Shall possess Ph.D. degree
- 2) Shall have at least fifteen years teaching experience in aggregate
- 3) Shall be a post graduate recognised teachers imparting teaching to post graduate students
- 4) Shall be a recognised Ph.D. Guide under whose supervision, at least two students have been awarded Ph.D. Degree
- 5) Shall have authored / co-authored at least two text books / reference books or shall have published at least three research papers in peer reviewed journals as first / corresponding author
- 6) Shall have undertaken university examination related work for at least five years in aggregate

 The candidate MUST attach the following documents with the nomination form to contest the election:
- 1) Attested photocopy of Ph. D. Degree
- 2) Attested photocopy of fifteen years teaching experience in aggregate from the Principal and University approval letter
- 3) Attested photocopy of letter of post graduate recognised teacher
- Attested photocopy of Ph. D. Guide letter
- 5) Ph. D. Degree or Declaration of Result of two students who have completed Ph.D. degree under the supervision of the candidate
- 6) Attested photocopy of first page of at least two books / reference books authored or three research papers published in peer reviewed journals as first / corresponding author
- 7) Certificate from the Director, Board of Examinations & Evaluation stating that the candidate has undertaken examination related work for at least five years in aggregate

The nominations are invited so as to reach the undersigned on or before <u>Saturday</u>, <u>25th February</u>, <u>2023 before 5:00 p.m.</u> at University office at Inward Section. The prescribed Nomination forms can be obtained from the University and also from website. It shall be dated and signed by any two electors as proposer / seconder and shall contain the details such as the names in full, addresses and designations, if any, of the signatories i.e. the proposer and the seconder and of the candidate nominated. No person shall be nominated as a candidate for election unless he / she signify his / her consent under his / her signature and the date on the nomination paper. No person shall either propose or second his own nomination.

Incomplete nomination form or the nomination form which does not comply with all the requirements as mentioned above shall be invalid and shall be rejected.

A person shall be disqualified from contesting the elections to any of the authorities for the reasons mentioned under section 64 of the Maharashtra Public Universities Act, 2016.

The scrutiny of the nomination forms shall be done on <u>Sunday, 26th February, 2023 at</u> <u>11:00 a.m. in the University Office</u>. The candidate or his / her agent duly authorized by him / her in writing in this behalf shall be entitled to be present at the scrutiny to be held at the University Office.

It shall be open to the candidate to withdraw his candidature from the election provided that the candidate send an intimation of withdrawal <u>before 5:00 p.m. upto Wednesday, 01th March, 2023</u> in writing, signed by the candidate and duly attested by the Magistrate or Principal of College or Head of Recognized Institution or the Head / Director of the University Department to the undersigned. The list of the candidates validly nominated for the election will be notified on the Notice Board of the University Office as well as on **University website i.e.** http://www.sus.ac.in after the expiry of the date of withdrawal of nomination.

The voter shall have to vote at the specified polling centre fixed by the university and not at any other polling centre.

The voting paper/s will be issued to the members present in the meeting on **08**th **March, 2023** <u>between 10:00 am to 06:00 p.m.</u> for the election of Chairman.

Printed forms of nomination will be supplied on payment of ₹50/- at the University Office. The nomination form is also available at University website http://www.sus.ac.in → ਜਿਧਤਯੂਨ दालन (पोर्टल) / Election Portal → Application form → Nomination form. The candidate who have downloaded the nomination form from University website, must have to pay ₹50/- in cash only, while submitting the form.
