### NOTICE OF ELECTION OF THREE HEADS OF THE DEPARTMENTS

Election of **THREE HEADS OF THE DEPARTMENTS IN COLLEGES** to the BOARDS OF STUDIES IN **ELECTRONICS ENGINEERING** by the Electoral Roll of Collegium of Heads of the Departments under Section 40 (2) (c) of the Maharashtra Public Universities Act, 2016.

In exercise of the powers conferred upon me under Sub-Section 6(d) of the Section 14 of the Maharashtra Public Universities Act, 2016, it is hereby notified for the information of Electoral Roll of Collegium of Heads of the Departments that elections of **THREE HEADS OF THE DEPARTMENTS** to the BOARDS OF STUDIES IN **ELECTRONICS ENGINEERING** by the Electoral Roll of Collegium of Heads of the Departments will be held on **Monday, 25<sup>th</sup> September, 2017**, under Section 40 (2) (c) of the Maharashtra Public Universities Act, 2016. The following eligibility conditions for candidate as directed by the Govt. of Maharashtra vide gazette dated 29<sup>th</sup> April, 2017.

- 1) Shall possess Ph. D. Degree, unless he is a Principal appointed as a Principal after 13/10/2000.
- 2) Shall have at least ten years teaching experience at undergraduate level in aggregate.
- 3) Shall have undertaken university examination related work for at least five years in aggregate.

The election shall be held by ballot at the polling centres. The list of polling centres along with places where voters are required to go in person for voting, are sent to the Principals of the affiliated Colleges / Recognised Institutions for information of all Heads of the Departments.

The candidate must attach the following documents with the nomination form to contest the election.

- 1) Attested photocopy of Ph. D. Degree / Declaration of Ph.D. if appointed as a Principal after 13/10/2000.
- 2) Certificate of Accreditation of college by National Assessment and Accreditation Council or National Board of Accreditation.
- 3) Certificate from the Director, Board of Examinations & Evaluation stating that the candidate has undertaken examination related work for at least five years in aggregate.

As provided under Section 62 of the Maharashtra Public Universities Act, 2016, the term of Office of the elected members shall be FIVE YEARS.

The nominations are invited so as to reach the undersigned on or before **Friday, 08<sup>th</sup> September, 2017 not later than 5:00 p.m.** The prescribed Nomination forms obtained from the University and also from website shall be dated and signed by any two electors as proposer / seconder and shall contain details the names in full, addresses and designations if any, of the signatories i.e. the proposer and the seconder and of the candidate nominated. No person shall be nominated as a candidate for election unless he / she signify his / her consent under his / her signature and the date on the nomination paper. No person shall either propose or second his own nomination.

Incomplete nomination form or the nomination form which does not comply with all the requirements as mentioned above shall be invalid and shall be rejected.

A person shall be disqualified from contesting the elections to any of the authorities for the reasons mentioned under section 64 of the Maharashtra Public Universities Act, 2016.

The scrutiny of the nomination forms shall be done on **Saturday, 09<sup>th</sup> September, 2017 at 11:00 a.m. in the University Office.** The candidate or his / her agent duly authorized by him / her in writing in this behalf shall be entitled to be present at the scrutiny to be held at the University Office.


It shall be open to the candidate to withdraw his candidature from the election provided that the candidate send an intimation of withdrawal **before 5:00 p.m. upto Tuesday, 12<sup>th</sup> September, 2017** in writing, signed by the candidate and duly attested by the Magistrate or Principal of College or Head of Recognized Institution or the Head / Director of the University Department to the undersigned. The list of the candidates validly nominated for the election will be notified on the Notice Board of the University Office as well as on **University website i.e. <http://su.digitaluniversity.ac>** after the expiry of the date of withdrawal of nomination.

The voter shall have to vote at the specified polling centre fixed by the university and not at any other polling centre.

The voting paper/s will be issued to the voter at the respective polling centre on **Monday, 25<sup>th</sup> September, 2017 between 9:00 a.m. to 4:00 p.m.** The voters coming after the specified time will not be given voting papers.

Printed forms of nomination will be supplied on payment of ₹50/- at the University Office. The nomination form is also available at University website **<http://su.digitaluniversity.ac>** → **निवडणूक दालन (पोर्टल) / Election Portal** → **Application form** → **Nomination form**. The candidate who have downloaded the nomination form from website, must have to pay ₹50/- in cash only.
