



SOLAPUR UNIVERSITY, SOLAPUR NOTICE OF ELECTION

Elections to the **MANAGEMENT COUNCIL** BY amongst the members of the SENATE as per the Maharashtra Public Universities Act 2016 under Section 30 (4) and as per the eligibility conditions published by the Govt. of Maharashtra in the Gazette dated 29th April, 2017 as under:

- [I] Two Principals of whom one shall be belonging to the category Scheduled Castes (under Section 30 (4) (f))
- [II] Two Teachers from amongst the teachers and University Teachers of whom one shall be belonging to the category Scheduled Castes (under Section 30 (4) (g))
- [III] Two Representatives of Managements of whom one shall be belonging to the category Scheduled Castes (under Section 30 (4) (h))
- [IV] Two Registered Graduates of whom one shall be belonging to the category Scheduled Castes (under Section 30 (4) (i))

In exercise of the powers conferred upon me under Sub-Section 6(d) of the 14 of Maharashtra Public Universities Act, 2016, it is hereby notified for the information to the members of Senate that, the elections of (1) Two Principals of whom one shall be belonging to the SC Category, (2) Two Teachers from amongst the Teachers and University Teachers of whom one shall be belonging to the SC Category, (3) Two Representatives of Managements of whom one shall be belonging to the SC Category, (4) Two Registered Graduates of whom one shall be belonging to the SC Category to the Management Council by amongst the members of the Senate. These Elections will be held in the Meeting of the Senate on **Monday, 13th November, 2017.**

The nominations are invited so as to reach the undersigned on or before **Thursday, 2nd November, 2017 not later than 5:00 p.m.** The prescribed Nomination forms obtained from the University and also from website shall be dated and signed by any two electors as proposer / seconder and shall contain details the names in full, addresses and designations if any, of the signatories i.e. the proposer and the seconder and of the candidate nominated. No person shall be nominated as a candidate for election unless he / she signifies his / her consent under his / her signature and the date on the nomination form. No person shall either propose or second his own nomination. A candidate contesting the election for reserved seats must submit a Caste Certificate from Tahshildar alongwith the nomination form.

The candidates who are contesting elections to Management Council from the Principals, Teachers, Representatives of Managements and Registered Graduates have already submitted the certificates of eligibility conditions as directed by Govt. of Maharashtra vide

Govt. Gazette dated 29th April, 2017 at the time of Senate Election in the above referred constituency. Hence, not necessary to attach the eligibility certificates with nomination form for this elections.

Incomplete nomination form or the nomination form which does not comply with all the requirements as mentioned above and in the Statutes shall be invalid and shall be rejected.

As provided under Section 62 of the Maharashtra Public Universities Act, 2016, the term of Office of the elected members shall be FIVE YEARS.

A person shall be disqualified from contesting the elections to any of the authorities for the reasons mentioned under section 64 of the Maharashtra Public Universities Act, 2016.

The scrutiny of the nomination forms shall be done on **Friday, 3rd November, 2017 at 11:00 a.m. in the University Office.** The candidate or his / her agent duly authorised by him / her in writing in this behalf shall be entitled to be present at the scrutiny to be held at the University Office.

It shall be open to the candidate to withdraw his candidature from the election provided that the candidates send an intimation of withdrawal **before 5:00 p.m. upto Monday, 6th November, 2017** in writing, signed by the candidate and duly attested by the Magistrate or Principal of College or Head of Recognised Institution or the Head / Director of the University Department to the undersigned.

The voting paper/s will be issued to the voter in the meeting of the Senate to be held on **Monday, 13th November, 2017 between 12:15 p.m. to 1:00 p.m.** The voters coming after the specified time will not be given voting papers.

Printed nomination forms will be supplied on payment of Rs.50/- at the University Office. The nomination form is also available at University website <http://su.digitaluniversity.ac> → निवडणूक दालन (पोर्टल) / Election Portal → Application form → Nomination form. The candidate who have downloaded the nomination form from website, he / she must have to pay Rs.50/- in cash only.
