



SOLAPUR UNIVERSITY, SOLAPUR NOTICE OF ELECTION OF TEN PRINCIPALS

Election of **TEN PRINCIPALS** to the SENATE by the Electoral Roll of Collegium of Principals under Section 28 (2) (o) of the Maharashtra Public Universities Act, 2016.

In exercise of the powers conferred upon me under Sub-Section 6(d) of the Section 14 of the Maharashtra Public Universities Act, 2016, it is hereby notified for the information of Electoral Roll of Collegium of Principals that elections of **TEN PRINCIPALS** by the Electoral Roll of Collegium of Principals to the SENATE under Section 28 (2) (o) of the Maharashtra Public Universities Act, 2016 will be held on **Monday, 25th September, 2017**. TEN PRINCIPALS shall be elected as under:

The following eligibility conditions for contesting the elections for candidate as directed by the Govt. of Maharashtra vide gazette dated 29th April, 2017.

- 1) Shall possess Ph.D. Degree, unless appointed as a Principal before 13/10/2000.
- 2) Shall be a Principal of a College which has valid Certification of Accreditation by National Assessment and Accreditation Council or National Board of Accreditation as the case may be and period of validity of such Certificate is unexpired.
- 3) Shall have undertaken university examination related work for at least five years in aggregate.

The election shall be held by ballot at the polling centers. The list of polling centers along with places where voters are required to go in person for voting, are sent to the Principals of the affiliated Colleges / Recognised Institutions for information of all Principals.

The candidate must attach the following documents with the nomination form to contest the election.

- 1) Attested Photocopy of Ph. D. Degree / Declaration of Ph.D. if appointed as a Principal after 13/10/2000.
- 2) Certificate of Accreditation of college by National Assessment and Accreditation Council or National Board of Accreditation.
- 3) Certificate from the Director, Board of Examinations & Evaluation stating that the candidate has undertaken examination related work for at least five years in aggregate.

As provided under Section 62 of the Maharashtra Public Universities Act, 2016, the term of Office of the elected members shall be FIVE YEARS.

The nominations are invited so as to reach the undersigned on or before **Friday, 08th September, 2017 not later than 5:00 p.m.** The prescribed Nomination forms obtained from the University and also from website shall be dated and signed by any two electors as proposer / seconder and shall contain details the names in full, addresses and designations if any, of the signatories i.e. the proposer and the seconder and of the candidate nominated. No person shall be nominated as a

candidate for election unless he / she signify his / her consent under his / her signature and the date on the nomination paper. No person shall either propose or second his own nomination. **A candidate contesting the Election for reserved seats must submit a Caste Certificate from Tahshildar along with the nomination form.**

Incomplete nomination form or the nomination form which does not comply with all the requirements as mentioned above shall be invalid and shall be rejected.

A person shall be disqualified from contesting the elections to any of the authorities for the reasons mentioned under section 64 of the Maharashtra Public Universities Act, 2016.

The scrutiny of the nomination forms shall be done on **Saturday, 09th September, 2017 at 11:00 a.m. in the University Office.** The candidate or his / her agent duly authorized by him / her in writing in this behalf shall be entitled to be present at the scrutiny to be held at the University Office.


It shall be open to the candidate to withdraw his candidature from the election provided that the candidate send an intimation of withdrawal **before 5:00 p.m. upto Tuesday, 12th September, 2017** in writing, signed by the candidate and duly attested by the Magistrate or Principal of College or Head of Recognized Institution or the Head / Director of the University Department to the undersigned. The list of the candidates validly nominated for the election will be notified on the Notice Board of the University Office as well as on **University website i.e. <http://su.digitaluniversity.ac> → निवडणूक दालन (पोर्टल) / Election Portal → Notification** after the expiry of the date of withdrawal of nomination.

The voter shall have to vote at the specified polling centre fixed by the university and not at any other polling centre.

The voting paper/s will be issued to the voter at the respective polling centre on **Monday, 25th September, 2017 between 9:00 a.m. to 4:00 p.m.** The voters coming after the specified time will not be given voting papers.

Printed forms of nomination will be supplied on payment of ₹50/- at the University Office. The nomination form is also available at University website **<http://su.digitaluniversity.ac> → निवडणूक दालन (पोर्टल) / Election Portal → Application form → Nomination form.** The candidate who have downloaded the nomination form from website, must have to pay ₹50/- in cash only.
