Mode of application: Online

Selection Process:

Two-tier selection process i.e. screening of eligible applications by an Internal Committee, followed by final selection through an Expert Committee shall be used. However, the selection process will be expected to complete within 6 months from the last date of submission of application at the DST and the result of the selection process will be communicated to individual selected candidate through online webportal (www.online-inspire.gov.in) only. No hardcopy of the Offer Letter (Provisional & Final) shall be sent to the candidate by any other modes.

Eligibility:

- •INSPIRE Scholar having secured minimum 65% marks in aggregate or equivalent CGPA at MSc or Integrated MS/ MSc course.
- •1ST Rank Holders at University Level Examination (not at Autonomous College Level examination) of overall full time post-graduate program in science, engineering /technology / agriculture / pharmacy / other applied science streams and undergraduate in Medicine i.e. MBBS. 
