
Sub: Connectivity to those Universities who have not paid their share for connectivity under NME-ICT Project reg.
Ref: This office Lr. No. 64-54 09-BB dt 17-08-2010 regarding connectivity to universities under NME-ICT Project.

Kindly refer to the above subject where in instructions were issued for the connectivity for the universities with the BSNL POP.

1. As per the terms and conditions of the NME-ICT Project, 10% of the 1Gbps connectivity charges for 10 years are to be borne by BSNL being partner in the Project. 75% of the balance 90% (Rs 1.35 Crores) is to be paid by MHRD. 25% of the 90% (i.e. Rs 45 Lakhs) is to be paid by the universities. The share between the MHRD and Universities will be 90% and 10% respectively in case of DONER states.
2. Ministry of HRD, in order to fasten the connectivity to the Universities and also BSNL has already carried out bulk of the core bandwidth augmentation required for providing the connectivity, has paid their share for the connectivity. But there is a delay in getting the payments from majority of the Universities.
3. Accordingly approval of the competent authority is conveyed for the following.
 - a. In case of private universities, existing procedure of providing connectivity after taking 25% university share (10% in case of DONER states) will continue. You may pursue with the Universities for getting the payments.
 - b. Many state Governments have written to Ministry of HRD that they are willing to make the payments. Hence in case of State Government Universities, where ever undertaking/guarantee is already received or can be taken from the universities (before extending the connectivity), connectivity may be provided without awaiting the 25% payments. In case of State Government Universities who are willing to make payments in installments also, the same procedure will continue.
 - c. However in parallel, you may pursue with the Universities for getting the balance payments as early as possible.
 - d. In case the State Government University fails to pay their share, the connectivity will be limited to the proportionate period for which payments have been made (less than 10 years).

4. You may ensure that the connectivity is completed before 31.09.2010 for all the universities.

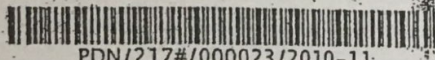
