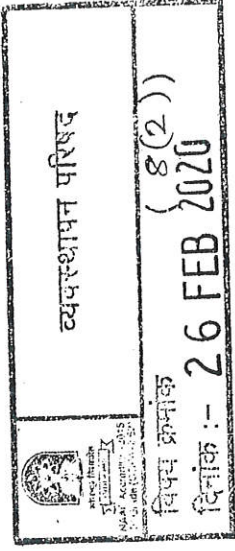

MEMORANDUM OF UNDERSTANDING

For

Collaborative Education Programmes & Joint Research Projects

BETWEEN

Punyashlok Ahilyadevi Holkar Solapur University, Solapur, India

AND

The University of Malta

Punyashlok Ahilyadevi Holkar Solapur University, Solapur, India was established on 1st August 2004 and was inaugurated on 03-08-2004 by the then Governor of Maharashtra. The formation of the university at Solapur was a long cherished desire of the people of this region. Earlier, to the formation of University, Solapur had a P.G. Centre of Shivaji University, Kolhapur for over two decades. The centre for P.G. studies had three postgraduate science departments and seven postgraduate courses conducted in the P.G. departments. With this sound background PAH Solapur University has been established to cater the needs of over 60,000 students' community.

The University is poised for an ambitious growth. The University is now a hub of various academic activities. Good numbers of Engineering, Agricultural, Architectural, Medical and Traditional institutions of national fame are located in and around the city. Solapur district is home of religious saints of various languages, since the district is at a triple junction of linguistic states of Telangana, Karnataka and Maharashtra. Therefore, Solapur is secular, multilingual and metropolitan to its core. This backdrop makes the University stands for transcendent principles and embodying noble mission. It is a small team yet progressive and forward-looking. Perched on a plateau, the PAH Solapur University is a citadel of higher learning. Recently the PAH Solapur University has introduced the concept of school system and has decided to bring its various departments under umbrella of seven schools, viz. 1) School of Chemical Sciences 2) School of Computational Sciences 3) School of Earth Sciences 4) School of Physical Sciences 5) School of Social Sciences 6) School of Commerce and management 7) School of Languages 8) School of Technology. To cater the need of the academic information the University has a full-fledged library housed in the premises measuring nearly 400 sq. Meters.

AND

THE UNIVERSITY OF MALTA is the highest teaching institution in Malta. It traces its origins to the founding of the Collegium Melitense which was set up through direct papal intervention on 12 November 1592. The University of Malta is publicly funded and is open to all those who have the requisite qualifications. The University's structures are in line with the Bologna Process and the European Higher Education Area. Conscious of its public role, the University strives to create courses which are relevant and timely in response to the needs of the country. There are some 11,500 students including over 1000 international students from 92 different countries, following full-time or part-time degree and diploma courses, many of which run on the modular or credit system. The University of Malta annually hosts around 450 exchanges students from its partner universities across the world.

Punyashlok Ahilyadevi Holkar Solapur University, Solapur, India and the **University of Malta** are each referred to individually as a "Party" and collectively as "Parties"

Introduction

Whereas believing in the significance of academic and cultural understanding and cooperation, **Punyashlok Ahilyadevi Holkar Solapur University, Solapur, India** and the **University of Malta** have decided to enter into a Memorandum of Understanding between the two Universities to enhance better relations and exchange of expertise to boost academic development for the general interest of students and staff.

This Memorandum of Understanding (MOU) shall delineate the main features of cooperation between the two Universities, particularly in academic development, research, exchange of students, faculty, and staff and development of educational opportunities to enrich campus internationalisation at each University.

THE UNDERSIGNED PARTIES agree to do the following activities with the cooperation of each other:

Article I

Punyashlok Ahilyadevi Holkar Solapur University, Solapur, India hereinafter referred to as 'PAHSU' and the **University of Malta** hereinafter referred to as 'UM' agree to explore the possibility of establishing a relationship in order to advance global understanding, research, teaching relationships as well as faculty and student exchanges.

Article 2

The Institutions shall explore the feasibility of developing a selected number of Summer internships for Post Graduate Students

Article 3

Masters' students of PAHSU may also pursue their dissertations at the UM and vice-versa and also have joint supervision of students' dissertations. This will be subject to the terms and conditions set by the home and partner Universities. PAHSU students may take some study units at the UM and vice-versa. Both Universities may recognise/accredit these study units and add these credits to the students' final credit count (subject to the approval from both the Universities). The PAHSU shall provide the final Master's degree to PAHSU students and vice-versa. Arrangements (including selection, admission, fees and transfer conditions) will be laid out in a separate agreement.

Article 4

The UM shall explore the feasibility of sending students to PAHSU to take specific courses at either Bachelors or Masters level. Similarly, PAHSU shall explore the feasibility of sending students to UM to take specific courses at either Bachelors or Masters level.

Article 5

The two Parties shall encourage the exchange of academic and administrative members of staff from both Universities for teaching and professional development, and/or research endeavour; and/or encourage staff to carry out non-residential partnerships to develop academic and scientific research in areas and fields of interest to both Parties.

Article 6

The two Parties agree to encourage to offer short, specialised courses and training sessions in areas needed by both Universities (for example, through short-term summer "Discovery" Programmes hosted on the campus).

Article 7

The two Parties shall encourage student visits from both Universities. All procedures and mechanisms to study, the cost and share of both Parties to implement these visits successfully shall be laid down separately by formal agreement.

Article 8

The two Parties shall encourage exchanges of ideas, processes and procedures in student life and campus leadership.

Article 9

One liaison officer from each institution will be appointed to follow up the implementation of the MOU and to brief the officials in both Universities about progress achieved.

Article 10

The two Parties will explore collaborative research projects and funding opportunities. Both PAHSU and the UM will share experiences and expertise with these projects to ensure better chances of getting grant proposals approved.

Article 11

The MoU shall be effective from the date of last signature.

Article 12

This Memorandum of Understanding reflects the respective institutions' commitments to the terms and conditions mentioned in the MoU. This MoU shall remain in effect initially for five (5) years and thereafter can be renewed for another five (5) years. This MoU may be amended or terminated at any time by either Party provided that written notice of termination or amendment is given by the notifying Party to the other Party before (90) days of the date on which the termination or the amendment is intended to become effective. The commitments, made before the date of termination of MoU, shall continue to be operative.
