सदर प्रशिक्षण कार्यक्रम ८ महिन्यांच्या कालावधीसाठी अनुसूचित जमातीच्या २५ विद्यार्थ्यांकरिता राबवावयाचे असून, सदर प्रशिक्षण केंद्र प्रस्तुत विद्यापीठात सुरु करावे लागणार आहे व त्यानुसार संबंधित विद्यार्थ्यांसाठी आवश्यक वर्गखोल्या, ग्रंथालय, व अभ्यासकक्ष व प्रशासकीय सेवक वर्ग इत्यादी बाबी विद्यापीठाकडून उपलब्ध करून द्यावे लागणार आहे व त्यासाठी लागणारा निधी हा उपरोक्त संस्थेकडून विद्यापीठास प्राप्त होणार आहे. त्यानुसार सदर प्रशिक्षण कार्यक्रम प्रस्तुत विद्यापीठात राबविण्यासाठी विद्यापीठामार्फत पत्र क्र. सोविसो / विशेष कक्ष / २०१८-१९ / ९६३१, दि.०३/११/२०१८ अन्वये संबंधितांना सहमती पत्र पाठविण्यात आले आहे. त्यानुषंगाने आदिवासी संशोधन व प्रशिक्षण संस्था, पुणे यांनी दि.२०/११/२०१८ रोजीच्या पत्रान्वये सदर प्रशिक्षण कार्यक्रम राबविण्यास मान्यता दिली असून, विद्यापीठ व आदिवासी संशोधन व प्रशिक्षण संस्था यांच्या सोबत करावयाचा "समन्वय" कराराचा मसुदा पाठविला आहे व सदर समन्वय करार रु.५००/- किमतीच्या स्टॅम्प पेपरवर लेखांकित मुद्रण करून प्राधिकृत अधिकाऱ्यांची स्वाक्षरी करून त्यांचे कार्यालयाकडे जमा करणेबाबत विनंती केली आहे.

त्यानुषंगाने सदर करारानुसार रु.१६,०५,०००/- एवढ्या योजनेचा आराखडा ८ महिन्यांच्या प्रशिक्षण कालावधीसाठी मंजूर करण्यात आला असून, खाली नमूद केलेल्या बाबींवर खर्च करण्यास मंजूरी देण्यात येत असल्याचे कळविले आहे. त्याचा तपशिल पुढीलप्रमाणे:

MEMORANDUM OF UNDERSTANDING

Sub: Providing coaching of UPSC (Civil Services) Examination २०१९, to
Scheduled Tribe candidates belonging to Maharashtra State.

This Memorandum of understanding is made on July २०१९ between Tribal Research and Training Centre, Maharashtra State Pune located at २८, Queen's Garden, Pune hereinafter called as the FIRST PARTY and Punyashlok Ahilyadevi Holkar Solapur University, Solapur having its registered office at Solapur hereinafter called as the SECOND PARTY

As per letter Noजावकक्र. आसंप्रसं/२०१८/ प्र.क्र. /का-४/ २५७७दिनांक : २०/११/२०१८ it is decided to provide financial support to the Punyashlok Ahilyadevi Holkar Solapur University, Solapur for conducting coaching classes for preparation of UPSC Civil Services Preliminary Competitive examination for the students belonging to Scheduled Tribes Community, Subsequently, as per the resolution referred at No. ३ above, coaching to the २५ selected candidates at Solapur, the second party has agreed to conduct the coaching classes for MPSC / UPSC Civil Services Examination.

Financial support to the SECOND PARTY, in the form of grant-in aid for conducting the coaching classes for preparation of UPSC Civil Services Examination, for duration ८ Months starting from July २०१९ to February २०२०. (Eight months) for २५ students shall be as under and the SECOND PARTY has accepted this.

The FIRST PARTY reserves its right to change the above mentioned item wise estimated expenditure in accordance with GR. This can be done to accommodate the deviation/ change in item wise actual expenses to be incurred by the SECOND PARTY and FIRST PARTY.

Both the parties to agreement will abide by the following terms and conditions:

SECOND PARTY must run the coaching classes for MPSC / UPSC (Civil Services) Examination from July २०१९ to February २०२०. to the candidates who have been selected by the SECOND PARTY through Common Entrance Test.

FIRST PARTY shall release ५० % of total funds to the SECOND PARTY against

the sanctioned accorded at the time of execution of MOU and balance 40 % during end of the term of the course provided that you submit all the documents.

SECOND PARTY will provide the list to FIRST PARTY of shortlisted qualified, experienced and competent resource persons for the coaching classes. In case, the FIRST PARTY wants to recommend any competent resource person, the SECOND PARTY shall furnish the resume and necessary documents of such resource persons to FIRST PARTY. The common list of faculty will be the panel of Resource persons impaneled for the Coaching Program. The SECOND PARTY will have the right to utilize their services as and when required and according to their availability.

The payment of resource persons shall be paid by the SECOND PARTY on the bases of attendance sent by SECOND PARTY to the FIRST PARTY.

SECOND PARTY shall impart quality coaching, conduct periodic tests and inform the result of the same to the FIRST PARTY.

The attendance reports of the candidate shall be sent every month by the SECOND PARTY to the FIRST PARTY so as to facilitate the SECOND PARTY to make the payment of monthly stipend to the candidates directly to their account without delay.

The attendance reports of the resource persons shall be sent every month by the SECOND PARTY to the FIRST PARTY. So as to facilitate the SECOND PARTY to

make the payment of remuneration to the Faculty members directly to their account without delay.

SECOND PARTY will cover all the Syllabus of the MPSC / UPSC Preliminary and Main Examination during the coaching classes.

Month wise Stipend of Rs. 8,000/- (Rs. Four Thousand Only) Per month per student shall be paid directly by the SECOND PARTY to the candidates who have been selected by the SECOND PARTY For undergoing coaching and having attendance of 64% and above, by depositing the amount directly or through Cheque in the account of eligible candidates.

The students will also be eligible for book kits per Sanctioned amount of Rs 6000/- (Six Thousand Only Once) Per Students and will be deposited directly by SECOND PARTY.

SECOND PARTY shall provide Classroom, Reading room, office, Library with proper ventilation, separate toilet facilities to girls and boys.

SECOND PARTY shall appoint a co-coordinator and necessary staff to run the centre. The payment of the Coordinator and other staff and examination expenditure as per MOU shall be paid by the SECOND PARTY after the prior approval of the FIRST PARTY. The Payments of the support staff would be made as per the provisions under Column No. 9 "Staff Remuneration and other expenses."

FIRST PARTY will have the right to inspect the infrastructure Facilities provided by the SECOND PARTY periodically. SECOND PARTY shall take action on the observations/suggestions made by FIRST PARTY.

FIRST PARTY will have the right to inspect the books of accounts related to coaching classes including the vouchers, cashbook. Bills, ledgers.etc. through its officers or the agency designated for the purpose.

FIRST PARTY shall have full powers to review the Coaching Classes and if at any time, the FIRST PARTY comes to the conclusion that the Coaching Classes are not being conducted satisfactorily, FIRST PARTY shall discontinue the Coaching Classes without calling explanation of the SECOND PARTY and the SECOND PARTY shall not be entitled to any payment towards damages.

SECOND PARTY shall make available library and book lending facility with internet, periodical, journals. Magazines, newspapers and latest publications on the areas/topics of the respective competitive examinations, to the selected students

SECOND PARTY shall maintain item-wise accounts for the expenditure on various components. SECOND PARTY shall submit Xerox copies of the bills duly certified by the competent authority in case demanded by the FIRST PARTY and at the end of the program Utilization Certificate duly signed and authorized by the

competent authority should be submitted to the FIRST PARTY

FIRST PARTY reserves right to undertake audit of the expenditure incurred by the SECOND PARTY at any time during or after the completion of the coaching classes.

FIRST PARTY reserves the right to amend or alter this MOU with the consultation of the University.

SECOND PARTY shall take the undertaking from the students that the students will not behave in an improper way during the entire period of training. In case of any misconduct on their part, either in the coaching classes or outside, during the period of training, the SECOND PARTY in consultation with FIRST PARTY reserves the right to impose penalty, including the cancellation of Admission / Sponsorship.

SECOND PARTY would be sole responsible for implementing Anti-Ragging Act in the University, based on the directions of the Hon'ble Supreme Court, UGC Regulations on curbing the menace of ragging in Higher Educational Institutions, 2008.

The SECOND PARTY in consultation with FIRST PARTY reserves the right to impose penalty/ Punishment could include expulsion from the University, suspension from the University for a limited period, a fine with a public apology, withholding of Stipend or scholarships, debarring from representation in events, suspension or expulsion from the hostel or mess.

This MOU shall be valid for 4 years and can be extended further mutually agreed upon by both the parties or can be terminated by serving prior notice of one month from the either party.
