(टिपणी: सरदार वल्लभ भाई पटेल यांच्या १४० व्या जयंती निमित्त मा. पंतप्रधान यांनी “एक भारत श्रेष्ठ भारत” या अभियानाची सुरुवात केली आहे. त्यास अनुसरून देशातील सर्व राज्यातील संस्कृतिची देवान-घेवाण व्हावी या उद्देशाने महाराष्ट्राने ओरीसा या राज्याबरोबर भागीदार राज्य म्हणून करार केला आहे. त्यास अनुसरून खालीकोट विद्यापीठ, बेरहमपूर यांच्यासोबत सोलापूर विद्यापीठास सामंजस्य करार करण्याबाबत तसेच “एक भारत श्रेष्ठ भारत” या अभियानाची प्रभावी अंमलबजावणी करण्यासाठी समन्वयक म्हणून नेमणूक करण्याबाबत शिक्षण संचालनालय (उच्च शिक्षण) पुणे यांनी कळविलेले होते. त्यानुसार प्रस्तुत विद्यापीठाकडून समन्वयक पदावर विद्यार्थी विकास संचालक, प्रा. एस. एन. शिंदे यांची नियुक्ती करण्यात आली आहे. तसेच सदर अभियानाची प्रभावी अंमलबजावणी होण्यासाठी नोडल ऑफिसर म्हणून नेमणूक केलेले शिक्षण संचालक, उच्च शिक्षण, पुणे यांच्या अध्यक्षतेखाली सर्व समन्वयकांची बैठक दि.११ जानेवारी, २०१८ रोजी पुणे येथे आयोजित करण्यात आली होती. सदर बैठकीत “एक भारत श्रेष्ठ भारत” या अभियानाची अंमलबजावणी करण्यासाठी खालीकोट विद्यापीठ, बेरहमपूर यांच्यासोबत करार करण्याबाबतचा मसूदा तयार करण्यात आला असून सदर मसूद्यास महाराष्ट्र सार्वजनिक विद्यापीठ कायदा कलम ६(३) अन्वये महाराष्ट्र शासनाची तसेच विद्यापीठातील व्यवस्थापन परिषदेची मान्यता घेणे आवश्यक आहे.

This Memorandum of Understanding is intended to promote the spirit of National Integration through a deep and Structured collaboration between Punyashlok Ahilyadevi Holkar (PAH) Solapur University, Solapur and Khallikote University, Berhampur through a year-long planned engagement between states, recognizing the benefits to their respective universities from the establishments of institutional links, hereby agree to enter into an agreement for the following purpose:

**1. PURPOSE OF AGREEMENT**

The purpose of this agreement is to create an environment which promotes learning between the universities by sharing best practices and experiences to develop cultural and educational cooperation, establish a collaborative program in between the two universities and to cooperate in their mutual interest for a range of higher educational activities.

**2. AREAS OF COOPERATION**

With the availability of resources and Financial implication from the respective universities and state government approval of the authorized representatives or heads of the PAH Solapur University, Solapur and the Khallikote University, Berhampur both universities agree to develop the following collaborative activities:



- A Organizing cultural and educational familiarization tour for the students and staffs of respective universities
- B Cooperation in individual projects
- C Organizing lectures, symposia, national meetings, conferences and workshops
- D Exchange programmes for writers and poets
- E Exchange of information on traditional agriculture practices and weather forecasting among students
- F Organizing optional classes in learning and sharing the language of Marathi and Odia.
- G Organizing different competitions like photography, literary competition etc. for students of respective universities
- H Encourage learning and exposure to traditional sports, arts and cultural practices between Maharashtra and Odisha
- I Exchange of information, teaching materials, technological and scientific publications
- J Providing opportunities for experts and researchers to deliver lectures
- K Exploring any other opportunities to collaborate in the future
- l) Organizing Blog Competitions on "Ek Bharat Shreshtha Bharat" website between the students of PAH Solapur University, Solapur and Khallikote University, Berhampur.

### 3. IMPLEMENTATION

- 3.1 All programme or activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed upon in writing including the necessary budget for the program of activity as the need may arise.
- 3.2 Each of the participating institutions shall be fully responsible financially for the activities carried out under its direction or by its staff, except as otherwise agreed upon by the parties.
- 3.3 The universities will designate one officer each who will develop and



coordinate specific programs or activities between them.

#### **4 INTELLECTUAL PROPERTY**

Both the partner universities will ensure that any results and publication originating from this collaboration will be joint venture available in both PAH Solapur University, Solapur and Khallikote University, Berhampur.

#### **DURATION AND RENEWAL OF AGREEMENT**

This Memorandum of Understanding will become effective immediately after signature by the representatives of both the universities, i.e., Solapur University, Solapur and Khallikote University, Berhampur, and the same is subject to revision /modification by mutual agreement.

#### **5 AMENDMENTS**

- 5.1 This Memorandum of Understanding may be amended by a written agreement signed by the representatives of both the universities.
- 5.2 In the event of any unforeseen incident during collaborative activities in either university, both the universities agree to negotiate a mutually acceptable solution.
- 5.3 Should any disagreement arise out of the application, interpretation of implementation of this agreement, the universities shall endeavor to exercise best efforts to negotiate their differences.

#### **6. TERMINATION OF AGREEMENT**

This agreement may at any time during its period of validity, be terminated by either party upon prior notice to the other in writing not later than three months before termination date, provided that such termination shall not effect the completion of any program or activity underway at the time the notice of termination is given.

#### **7. APPROVAL**

In agreement with the above terms of participation authorized representatives of the PAH Solapur University, Solapur and Khallikote University, Berhampur hereby
