



NOW THEREFORE: Considering these legal and institutional relations, the successful implementation and operation of the Foreign Language Certified Courses affiliated to PAH Solapur University requires the partnership between the signatories which this MoU shall facilitate. The parties therefore have entered into this Memorandum of Understanding (herein-after referred to as "MoU") for the grant of approval to conduct Foreign Language Certified Courses jointly certified by Punyashlok Ahilyadevi Holkar Solapur University, Solapur

ARTICLE I: BACKGROUND & PURPOSE OF THIS MoU

Background

Punyashlok Ahilyadevi Holkar Solapur University is a State University located in Kegaon, Solapur, Maharashtra India. Formerly it was a postgraduate center of Shivaji University, Kolhapur. Punyashlok Ahilyadevi Holkar Solapur University was established on 1st August 2004 and was inaugurated on 3rd August 2004 by the honourable Governor of Maharashtra. The Objectives are

- 8. The Objective Type Exams will be conducted in March, June, September and December every year in collaboration with Skill Development Centre PAHSUS.
- To understand the aspects like pronunciation and flow of the spoken language, Viva
 assessments in the form of audio/video submissions will be conducted with additional
 practical exam fees.
- 10. The Online Exam Tool is Browser based and hence the exam can be given through Windows (PCs, Laptops), IOS (iPhone, iPad, Mac laptops) and/or Android (Cell phones, tabs) based platforms.
- 11. On clearing every course (Objective exam and Viva assessment both), the candidate will receive an Evaluation Mark-sheet and Certificate with logos of SDC, PAHSUS and FLOA.

1. Responsibilities & Scope of Punyashlok Ahilyadevi Holkar Solapur University

- To Provide Accessibility for the said Courses
- Contacting and Intimating all the Colleges & encouraging the students of those colleges to attend the said Program.
- Providing printed Mark sheets & Certificates with logos of SDC, PAHSUS and FLOA for the said course.

2. Responsibilities & Scope of FLOA (Enclosed syllabus)

- FLOA shall design the said courses as per the norms of SDC, PAHSUS and execute
 the same online.
- FLOA shall provide basic course material in the form of Recorded Videos,
 Downloadable Booklets and carry out induction program for coordinators.
- FLOA shall conduct examinations in association with SDC, PAHSUS and generate result and provide it to SDC, PAHSUS along with the certificates.
- FLOA will conduct Live Online training for the students with additional fees.

ARTICLE III: CO-ORDINATION AND NODAL OFFICER (MOU)

- 1. Objective Exam Fees, Practical (Viva assessment Fees) and Live Online Training Fees mentioned above are inclusive of GST @ 18%.
- 2. Fees Distribution: Out of the Total generated fees,
 - a) Refundable Security Deposit of INR 15,000/- will be paid to SDC, PAHSUS by FLOA one time.
 - b) Non Refundable Course Affiliation Fee of INR 5,000/- per course for the duration of 3 years will be paid to SDC, PAHSUS by FLOA.
 - c) INR 40/- of the collected Online Training and Exam Fees for Basic Certificate Course per student per language will be transferred to PAHSUS as Organization share.
 - d) INR 160/- of the collected Online Training and Exam Fees for Diploma Certificate per student per language will be transferred to PAHSUS as Organization share.
 - e) INR 40/- of the collected Practical (Viva Assessment Fees) will be transferred to PAHSUS as Organization share.
 - f) Certificate and Marksheet printing fees to be collected by FLOA and transferred to SDC, PAHSUS.
 - g) <u>70</u>% of Live Online Mentoring Fees to be retained with FLOA & <u>30</u>% of the Live Online Mentoring Fees should be remitted to Punyashlok Ahilyadevi Holkar Solapur University as soon as FLOA starts its Live Online Training Batches.

ARTICLE VII: CONFIDENTIALITY

Each partner shall not, while performing the Work or at any time thereafter utilize in any manner prejudicial to or incompatible with the interests of Punyashlok Ahilyadevi Holkar Solapur University & FLOA which may come to its knowledge in connection with the performance of this MoU

ARTICLE IX: RESOLUTION OF DISPUTES

- Any dispute or controversy which cannot be resolved by mutual agreement within 60 days or any claim arising out of or relating to this MoU, or the breach, termination or invalidity thereof shall be settled by arbitration in accordance with GOT Laws. The place of arbitration shall be at Solapur.
- b) In case of the premature termination of this MoU due to violation of any terms by

FLOA it shall be sole responsibility of FLOA to conduct the immediate exam cycle

Punyashlok Ahilyadevi Holkar Solapur University, Solapur. or to refund the Objective Exam fees, Viva Assessment fees and 60% share of Live Online training fees amount to the students who have taken admission and are unable to complete immediate exam cycle due to this situation.

- PAHSUS, it shall be the sole responsibility of PAHSUS to cooperate with FLOA to conduct the immediate exam cycle or in case otherwise FLOA is not entitled to pay the share of Objective Exam fees, Viva Assessment fees and 40% share of the Live Online Training fees for the immediate exam cycle to PAHSUS.
