This Memorandum of Understanding (MoU) is effective as of December 2022 to establish an affiliation by and between

BV(DU) Abhijit Kadam Institute of Management and Social Sciences, Solapur (AKIMSS, Solapur) is a premier leading B-School in Western Maharashtra located in Solapur. The institute is approved by AICTE, recognized by UGC and is under the umbrella of Bharati Vidyapeeth (Deemed to be University). Pune (India). AKIMSS has a well-established history and prides itself on its academic reputation. It's been set up in 1981, AKIMSS has emerged as a citadel of learning and research with a symbiotic relationship with the worlds of business and industry.

and

Punyashlok Ahilyadevi Holkar Solapur University was established in 2004. The formation of the university at Solapur was a long-cherished desire of the people of this region.

Both institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both institutes shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing.

Any publication regarding such intellectual property shall only be possible with the prior written consent of both institutes, such consent not to be unreasonably withheld.

AKIMSS shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, and publication purposes without the payment of royalties or other fees to the other party.

#### ARTICLE 5: VALIDITY

The Memorandum shall remain in force for a period of THREE years commencing from effective date. Both may extend the term by written agreement signed by both after review.

#### **ARTICLE 6: TERMINATION**

Either of both may terminate the MoU by giving written notice of six months in advance to the other institution. Once terminated, neither BVDU AKIMSS nor SCS PAHSU will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, BVDU AKIMSS and SCS PAHSU will ensure that the provisions of this Memorandum shallcontinue to apply to all activities in progress until their completion.

#### ARTICLE 7: AMENDMENTS/MODIFICATIONS

This MoU may be amended or modified by a written agreement signed by the representatives.

#### ARTICLE 8: ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the institutions.

### ARTICLE 9: LEGAL EFFECT

Nothing in this Memorandum shall be construed as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

## ARTICLE 10: DISPUTE RESOLUTION

In case there is a dispute relating to any aspect of academic cooperation, Director, BVDU AKIMSS and PAHSU SCS will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.



BVDU AKIMSS and SCS PAHSU welcome the establishment of this Memorandum for cooperation andjointly agree to the provisions as set out above.
