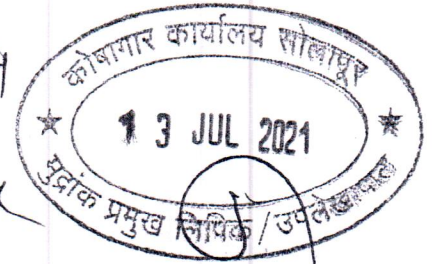


This Memorandum of Understanding (hereinafter caked as the 'MOU') is entered into on this the (Date 11 3 OCT 2021) by and between

Clause - 2

SCOPE OF THE MoU


INTELLECTUAL PROPERTY


