Full papers must be written in English and submitted only in MS Word format, with a length of 2,500–3,500 words including figures, tables, and references. All manuscripts should be formatted in Times New Roman, 12-point font, with 1.5 line spacing, and follow the latest APA citation style. Papers submitted without an abstract will not be considered for review.

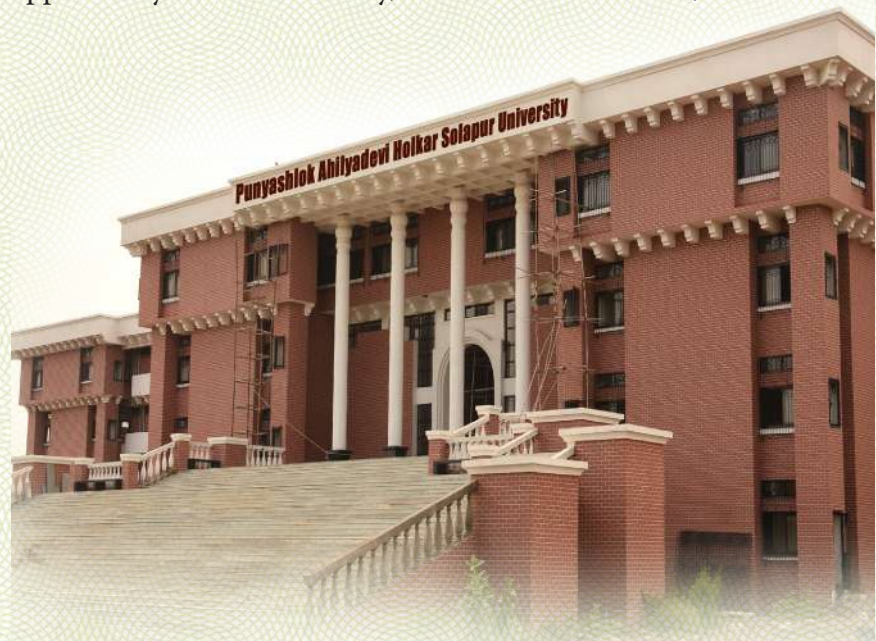

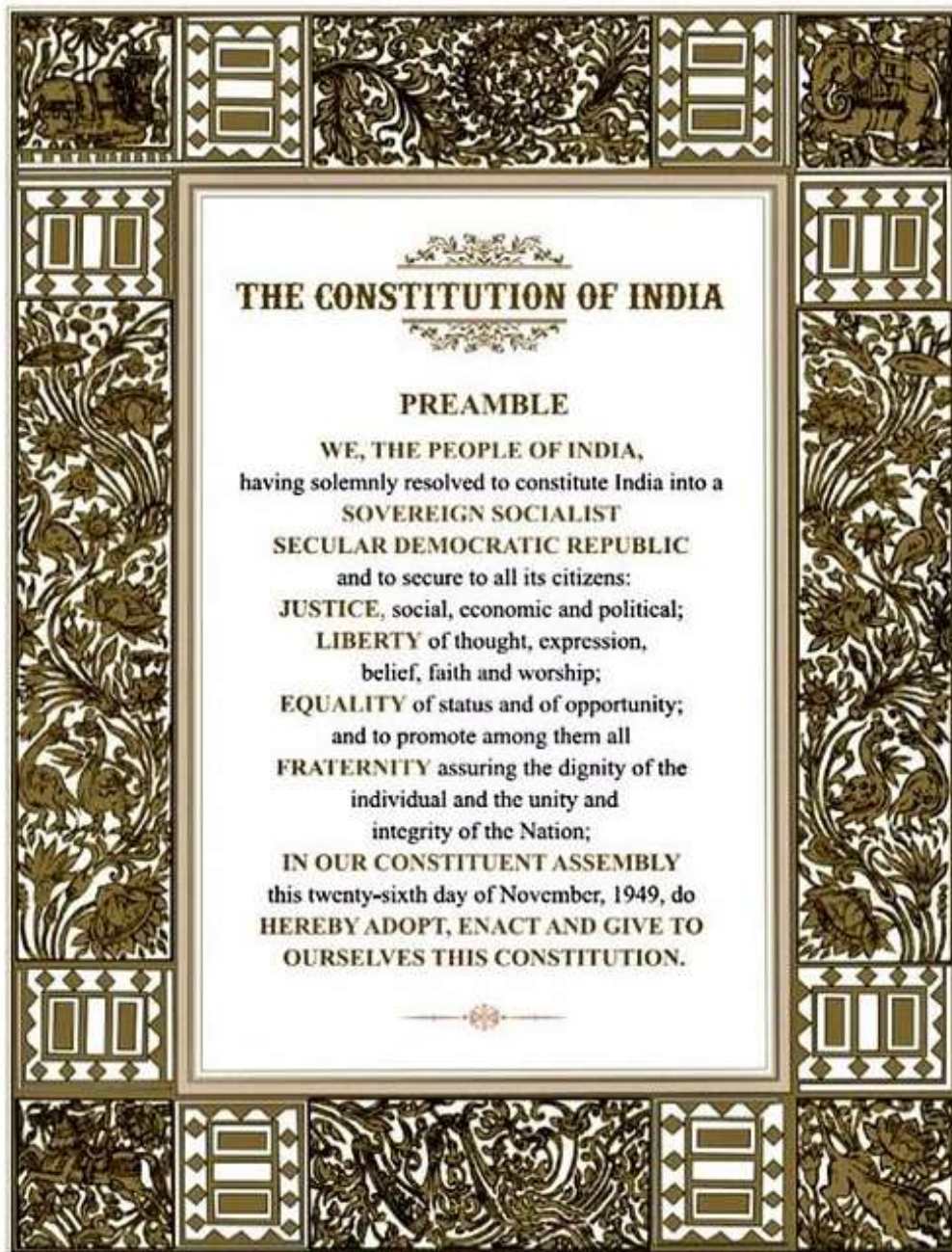
