SECTION- 3 CALL BACK SERVICE	
3.1	EMERGENCY MINOR ADJUSTMENT CALL BACK SERVICE: ELEVATOR will provide emergency minor adjustment CALL-BACK Service at no charge under this Quotation. This CALL-BACK Service will be extended 24 hours on all working days as well as holidays for elevators and escalators located in cities/towns where ELEVATOR has a service center.
SECTION 4-CUSTOMER'S OBLIGATIONS	
4.1	Access: The customer hereby agrees to provide the company with unrestricted ready and safe access to all areas of the Building in which any parts of the covered equipment are located and to keep all machine rooms and pit areas free from water, stored materials and debris. As we are merely executing engineering related works on behalf of yourselves, for the maintenance of the equipment, you shall be fully responsible for obtaining necessary and periodic inspection reports, approvals etc, whatsoever, as and when required from the lift inspectorate authorities, various other authorities etc. and to comply with any other government related obligations being mutually imposed on us in order for the maintenance of the equipment. All related expenses in connection with obtaining such reports, approvals, licenses etc., whatsoever are

	not included in our price.

4.3	<p>LIGHTING/VENTILATION:</p> <p>We agree to provide the machine room with adequate lighting, cooling, moisture control, and/or ventilation as required to assist its men in providing the work set out hereunder and in enhancing the effective operation of THE EQUIPMENT.</p>

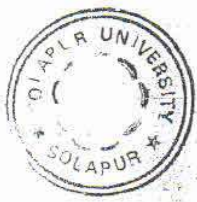
