Party 1-Samvardini Nyas, New Delhi

Samvardhinee Nyas is a wing of Rashtra Sevika Samiti; a cultural body dedicated to celebrate Matru Shakti and pursue all round physical, mental, intellectual and spiritual development of Bhartiya women. Bringing together women in all their hues and with all their strengths, making them confident, self-reliant and empowered, and harnessing their intellect, tenor, inherent wisdom, fortitude and creativity in pursuit of nation building is the core value of the Nyas.

Party 2 -Doon University, Dehradun

Doon University, Dehradun is a state university dedicated to impart socially and economically relevant education in order to provide lead in frontier areas of teaching and learning. The university has done reasonably well by establishing itself firmly in a relatively shorter period of its academic journey of 12 years. The university offers Undergraduate, Postgraduate and Ph D programmes across nine schools.

Party 3-Shreemati Nathibai Damodar Thackersey Women's University, Mumbai

SNDT Women's University is first Women's University of India and Southeast Asia. With 100+ years of its existence, the University has a rare privilege of 'national jurisdiction' with prior State approval. SNDTWU being multidisciplinary public University is engaged in teaching, research and extension related activities across diverse range of subjects through 40+ University Departments. 10+ Conducted colleges/institutions and 190+ affiliated colleges across six states and a union territory of India. It is a unique institution having KG to PhD coverage having "Sanskrita Stree Para Shakti" as motto.

Subsequently referred SN as Party-1, DUD as Party-2 and SNDTWU as Party-3 and jointly referred as "all the Parties" and Organising entering into "Letter of Intent" with 'all the Parties' referred as 'third party'.

The Objective

An International Conference in the form of "Maha Yagnya" is proposed to be held in the third week of April 2022 at Doon University Dehradun. Samvardhini nyas , a wing of Rashtra Sevika Samiti, Doon University and SNDT Women's University, Mumbai have collaborated to make this conference a reality. The aim of the conference is to highlight the strengths of Indian women and to

promulgate Bhartiya perspective of womanhood. Challenges and situations faced by Bhartiya women are much different than that are portrayed by the western researchers. Number of Organisations/Institutions are partnering for this conference.

Following are the terms of reference for different types of collaborations available to the 'Third party' organisations.



A. The Nature of Partnership and concept of Pre- conference

Third Party Organisations/institutions can collaborate for the said conference in following manners depending upon mutually acceptable terms of reference.

1. The MOU would be signed among both the institution with partnership fees of Rs. One Lac. (Bhartiya Institutions) & 5000\$ US Dollars with international Institutions.
The partnering Institutions logo will shared on banner of main conference and registration fees for 5 faculties from the partnering institution will be exempted .
3. The Institution has to conduct one pre -conference/seminar/symposia/webinar on at least one of the themes of the conference “ Bhartiya Women : A True Perspective “ at their campus. The conference team will facilitate the program with the resource persons.
4. The Institution should use the main conference logo and theme on the banner and certificate along with their institution's logo & subtheme in pre-conference/seminar/symposia/webinar.
5. The certificates for pre-conference/seminar/symposia/webinar should be issued by Organizing institution.
6. Partnering Institution has to take responsibility to register at least 25 participants for main conference scheduled in April 2022.

B. Tenure and Termination

This LOI will take effect from the date it is signed by respective third party. It will be confined to the proposed conference mentioned in this LOI only. It will remain valid till the end of the Conference.

C. Financial Terms

The Institution has to do the electronic transfer of Rs. One Lakh to the conference account within two working days from the date of signature of MOU. The MOU stands nullified if the Fees is not paid within two working days' time.



D. Arbitration Clause

Should there be a dispute relating to any aspect of academic cooperation, all the Parties along with the Third Party will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.
