You are requested to fill up the Questionnaire and submit the same on the above website. Please ensure that the data filled-in is accurate and complete in all respects.

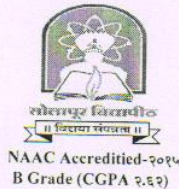


**PUBLIC NOTICE**
