If eligible candidate belonging to the concerned reserved category is not available against the aforesaid reservation, the candidates who appear for the interview shall be considered for selection for the concerned subject strictly on the basis of their merit.

GENERAL CONDITIONS & MINIMUM QUALIFICATIONS

1.	Candidates should apply online only from 08/09/2026 to 17/09/2026 through the University website https://pahsurecruitment.studentscenter.in
2.	Completed Application should be submitted online on or before 17/09/2026 & hard copy of the submitted application should be submitted at the time of reporting desk.
3.	Candidate should submit the hard copy of application form along with all enclosures at the time of interview for verification.
4.	The minimum qualification for post is as per UGC/AICTE/Government norms as the case may be.
5.	A relaxation of 5% may be provided from 55% to 50%, at the Master's level for S.C./S.T./VJ-NT/SBC/O.B.C. (Non-creamy Layer) / Differently abled category (Divyang).
6.	Relaxation of 5% may be provided, from 55% to 50%, to the Ph.D. holders, who have passed their Master's degree prior to 19 th Sept., 1991.

7.	4% reservation will be observed for PWD (Divyang) candidates as per Government Resolution dt. 29.05.2019.
8.	30% reservation for women shall be observed as per Government norms.
9.	As per Government Resolution VJ/NT Category are interchangeable.
10.	As the nature of appointment is purely temporary, if the reserved candidates from respective categories are not available for the aforesaid reserved posts these posts will be filled in through other candidates as per merit.
11.	Candidates from reserved category, who are domiciled outside the Maharashtra State will be treated as Open Category candidates as per Government resolution.
12.	Application fee is Rs. 500/- (non-refundable) for General, EWS, SEBC candidates and Rs. 250/- (non-refundable) for SC/ST/VJ-NT/SBC/OBC/PWD (Divyang) candidates.
13.	Separate application should be submitted for each post.
14.	The application form shall be rejected and no communication in this regards shall be made in case; a) the candidate does not possess essential academic qualifications and / or experience, b) the candidate exceeds the maximum age limit prescribed for the post c) self-attested copies of essential documents and certificates such as qualifications, experience, age are not enclosed.
15.	The essential qualification, experience and age of the applicant shall be taken into consideration as on the last date of submission of application form.
16.	The Punyashlok Ahilyadevi Holkar Solapur University, Solapur reserves all rights regarding increase or decrease in number of posts, correction, addition or deletion in advertisement and cancellation of whole advertisement.
17.	Any change/modification in the advertisement shall be uploaded on the University Website http://sus.ac.in → Establishment → Recruitment or Employment Opportunity only. Therefore, the applicants are instructed to check the website regularly.
18.	The University reserves the right not to fill up any post(s) even after selection of a candidate(s) thereof.
19.	Also, if the number of students admitted for a subject fall below 50%, the University reserves the right to order the appointment of candidates for such subjects.
20.	Candidate must furnish the detailed information regarding suspension, removal from previous service or any criminal prosecution against him/her or nature of punishment ordered thereof.
21.	If at any time after appointment, it is found that the candidate has submitted false information document, his/her appointment shall be terminated without prior information/notice.
22.	A candidate furnishing incorrect or false information shall stand disqualified at any stage.
