## **SEARCH-CUM-SELECTION COMMITTEE INVITES APPLICATION FOR THE POST OF “VICE-CHANCELLOR”**

The Punyashlok Ahilyadevi Holkar Solapur University is a young state University of Maharashtra state, established on 1st August 2004. The formation of the University at Solapur was a long cherished desire of the people of this region and the people of the district have an emotional attachment to the University since its inception. The University is currently located on the outskirts of Solapur city about 10 km from the main city, on the national highway NH-09 towards Pune. The University was recognized under section 2 (f) and 12 (b) of UGC Act, 1956 and is currently incorporated under the Maharashtra Public Universities Act, 2016.

His Excellency the Governor of Maharashtra, in his capacity as the Hon'ble Chancellor of this University, has constituted a Search-cum-Selection Committee to recommend names of suitable persons for the consideration of the Chancellor for being appointed as the Vice-Chancellor. The said Search-cum-Selection Committee is hereby inviting nominations/applications from eminent academicians who fulfill the qualifications and experience required for the post of Vice-Chancellor as prescribed under Section 11(3)(f) of the Maharashtra Public Universities Act, 2016 and willing to take on this prestigious assignment. All the necessary details regarding essential qualifications and experience for the post of Vice-Chancellor together with application format and an extract of Section 11 of the Maharashtra Public Universities Act, 2016 are available on the URL : <http://www.sus.ac.in/estd/Recruitment-OR-Employment-Opportunities> as well as the website of Punyashlok Ahilyadevi Holkar Solapur University, Solapur ([www.sus.ac.in](http://www.sus.ac.in)).

The candidates desirous of applying for the post are required to visit the above URL to acquaint themselves of the essential qualifications and experience for the post, as also the terms and conditions for the appointment to the post of Vice-Chancellor. Only such candidates who fulfil the laid down essential qualification and experience and are willing to accept the assignments, can apply for the post as per the format of the application together with (i) Summary of Details (Annexure-1), (ii) No Objection Certificate (Annexure-2), and (iii) Vigilance Clearance Certificate (Annexure-3), the formats of which are also available on the above URL. The application form along with all requisite documents

arranged chronologically (in *.doc as well as .pdf* format) and completed in all respects should not be more than fifteen (15) pages and must be placed on 'Google Drive', the link of which is to be mailed to the Nodal Officer on *email ID* ([nodalofficer.sus@gmail.com](mailto:nodalofficer.sus@gmail.com)) and a hard copy thereof is to be sent by post/courier in an envelope super-scribed with “**Application for the post of Vice Chancellor, Punyashlok Ahilyadevi Holkar Solapur University, Solapur**” so as to reach the Nodal Officer at his following address **on or before 20/07/2023** :-

Institutions may also nominate suitable candidates, while the Search-cum-Selection Committee may also invite deserving candidates to apply for the post. However, all such candidates shall be required to send their CV in the prescribed format so as to reach the Nodal Officer on or before 20/07/2023.

Only such of the candidates will be short-listed for interaction with the Search-cum-Selection Committee who will be found to be eligible and suitable for the post of Vice-Chancellor of the University. A list of short-listed candidates would be published on the website of the University in due course. Such short-listed candidates would be required to submit two pages write-up about their suitability for the position, two pages write-up about their vision for the University and names of the three referees along with reference letters. During interaction with the Search-cum-Selection Committee they may be required to make a brief presentation highlighting their achievements and their vision for the University.

The applications received after the prescribed date shall not be considered by the Search-cum-Selection Committee.

Any attempt by an applicant to influence or contact the Chairman or the Members of the Committee shall be treated as a disqualification for the candidate.
