



Direct recruitment -

A) Qualification for Arts, Sciences, Social Sciences, Commerce, Journalism and Mass commu. & Yoga

Post – ASSISTANT PROFESSOR

A.

- 1) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- 2) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET:

Provided the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the existing Ordinances/Bye-laws/ Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a) The Ph.D. degree of the candidate has been awarded in regular mode only;
- b) The Ph.D. thesis has been evaluated by at least two examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal; and
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/ seminars, sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

Note:

- 1) The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic affairs) of the University concerned.
- 2) NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.

The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- (i) Quacquarelli Symonds (QS);
- (ii) the Times Higher Education (THE) or
- (iii) the Academic Ranking or World Universities (ARWU) of the Shanghai

Jiao Tong University (Shanghai).

Note: The Academic score as specified in Appendix II (Table 3A) for Universities, and Appendix II (Table 3B) for Colleges, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

- 2. The minimum qualification for post is as per UGC/AICTE/Government norms as the case may be.
- 3. A relaxation of 5% may be provided from 55% to 50%, at the Master's level for S.C./S.T./VJ-NT/O.B.C. (Noncreamy Layer) category.
- 4. Relaxation of 5% may be provided, from 55% to 50%, to the Ph.D. holders, who have passed their Master's degree prior to 19th Sept., 1991.
- 5. As the nature of appointment is purely temporary, if the reserved candidates from respective categories are not available for the aforesaid reserved posts these posts will be filled in through open candidates.
- 6. Candidate Forward scanned copy of the relevant certificates of the educational qualifications, work experience and testimonials on or **before 28/06/2021** through email to est.section@sus.ac.in for verification with application form in the prescribed format.
- 7. Mode of Walk-in-Interviews: Through online platform (video conferencing e.g. zoom, google meet etc.)
- 8. Application fee is Rs. 500/- for General, EWS candidates and Rs. 250/- for SC/ST/VJ-NT/OBC/PWD (Divyang).

- 10. Receipt of payment of online application fee must be attached with the application form, otherwise your application will not be accepted as incomplete.
- 11. Separate application should be submitted for each post.
- 12. The application forms received through only e-mail shall be accepted.
- 13. Incomplete applications and the applications received after the last date as prescribed in the advertisement shall be rejected and no correspondence in this respect shall be entertained.
- 14. The application duly signed by the candidate shall only be entertained.
- 15. The candidates are advised to fill-in the prescribed application form completely in legible handwriting or in typewritten form. Incomplete and illegible application forms and those that are not in the prescribed format shall be rejected.
- 16. The application form shall be rejected and no communication in this regards shall be made in case; a) the candidate does not possess essential academic qualifications and/ or experience, b) the candidate exceeds the maximum age limit prescribed for the post, c) self-attested copies of essential documents and certificates such as qualifications, experience, age are not enclosed, d) the details of the payment of the requisite fee is not enclosed, e) If the application is not signed by the candidate.
- 17. The essential qualification, experience and age of the applicant shall be taken into consideration as on the last date of submission of application form.

- 20. The University reserves the right not to fill up any post(s) even after selection of a candidate(s) thereof.
- 21. Candidate must furnish the detailed information regarding suspension, removal from previous service or any criminal prosecution against him/her or nature of punishment ordered thereof.
- 22. Government employee and the staff working under the Universities and other institutes/organizations should necessarily submit their application through proper channel.
