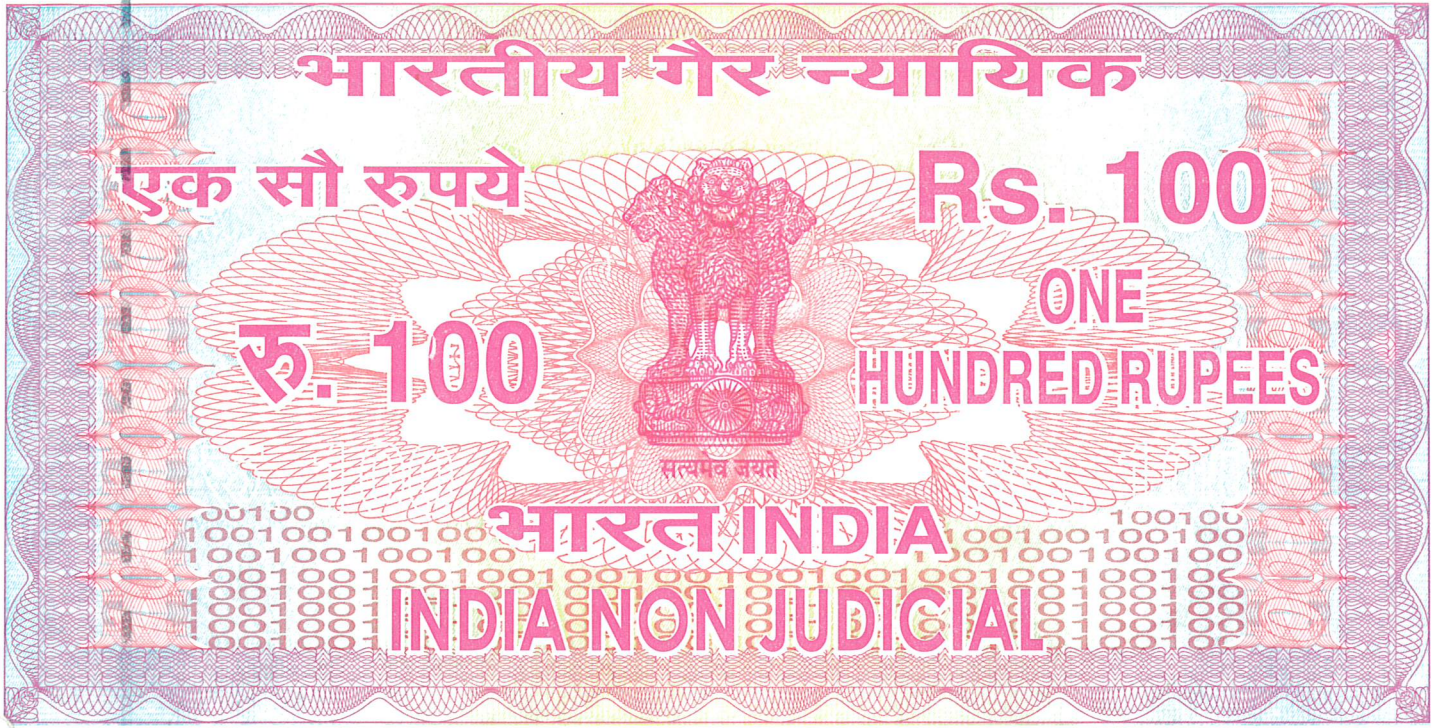

5. The Schedule of 38 Days will be providing internship for the candidates (without remunerations & provided experience letter) who have successfully passed the examinations.
6. The Said course shall require Monday to Friday 2 Hrs Each Day Time period.

The Below guidelines of the 150 Days Fashion Designing & Beautician course: -

1. The Course shall be of 150 days all inclusive of Govt Holidays and Saturday Sunday..
2. The schedule of 60 Days will be theoretical training within the classrooms.
3. The Schedule of 60 Days will be practical training within the class rooms.
4. The schedule of 30 Days shall be hands on training, where students will be taught the practical aspects of Fashion Designing Beautician Classes.
5. The schedule of 7 Days will be examination & results (oral & written)
6. The Schedule of 2 Days will be providing Industry visit for the candidates (without remunerations & provided experience letter) who have successfully passed the examinations.
7. The Said course shall require Monday to Friday 2 Hrs Each Day Time period.

1. The Course shall be of 300, 600days all inclusive of Govt Holidays and Saturday Sunday..
2. The schedule of 15 Days will be theoretical training within the classrooms.
3. The schedule of 15 Days shall be hands on training on site, where students will be taught the practical aspects of Fashion Designing Beautician & Makeup Classes.
4. The schedule of 7 Days will be examination & results (oral & written)
5. The Schedule of 38 Days will be providing internship for the candidates (without remunerations & provided experience letter) who have successfully passed the examinations.
6. The Said course shall require Monday to Friday 2 Hrs Each Day Time period.

1. Responsibility & Scope of Punyashlok Ahilyadevi Holkar PAH Solapur University

- To Provide Accessibility for the said course.
- Contacting the colleges & encouraging regarding attending the said programme.
- Providing Mark sheets of PAH Solapur University for the said course.

2. Responsibility & Scope of ISFT & PAH Solapur University, Solapur. (Enclosed Syllabus)

- ISFT shall design course after getting the final approval of PAH Solapur University, Solapur. Execute the same.
- ISFT shall provide basic course material, Training staff, and place to conduct the classes.
- Under the guidance of University, ISFT shall conduct examinations and results along with certificates.

ARTICLE III: Co ordination and Nodal Officer (MOU)

In Pursuit to this MOU, the Partners agree as follows:

Both Entities shall mutually decide and designate the Nodal Officer. The Nodal Officer will have responsibility for fulfilling the objectives of this agreement & will also monitor all the activities mentioned in this agreement.

ARTICLE IV: DURATION

The Duration this MOU shall be valid for 3 Years from the date of signatures of both the parties. The parties may extend this MOU on written consent in future. After This MOU no any other institute will be eligible in Solapur district to Run Institute in Fashion Designing, Makeup, Beautician Courses with Punyashlok Ahilyadevi Holkar University (PAH Solapur University) till this agreement continues. Thus the course fees shall be mutually agreed in future in case of any inflation on any aspects of the course requirements.

All the parties shall conform to all applicable laws and regulations of the government of India and respect in all circumstances the basic principles governing the education industry.

ARTICLE VI: TERMS AND CONDITIONS

1. Course Duration & Fees:
 - a. (One Year) Diploma in Fashion Designing: Rs 5000/- Excluding examination Fees & 18% GST.
 - b. (Two Year) Advance Diploma in Fashion Designing: Rs. 5000/- Excluding examination Fees & 18% GST.
 - c. (Six Months) Hair Skin & Makeup: Rs 2000/- Excluding examinations Fess & 18% GST.
 - d. (Six Months) Fashion Designing & Boutique Management Rs. 2000/- Excluding examinations Fess & 18% GST.
2. Course Eligibility: 10th, 12th & degree & Diploma (Technical) in any sector.
3. Age Limit: 18-50 Years
4. Language of Examinations: English & Hindi, Marathi.
5. Batch Strength : 50-100 Students
6. Working Days: Monday to Friday 2 Hours.
7. Course Venue: Private Study Hall in scope of ISFT Shall depend on availability)

ARTICLE VII

Course Fees Distribution: Out of the Total Fees generated. 80% of total fees to be provided to ISFT & 20% of the total fees should be provided to Punyashlok Ahilyadevi Holkar PAH Solapur University. (For one year)

CONFIDENTIALITY

Each partner shall not, while performing the work or at any time thereafter utilize in any manner prejudicial to or incompatible with the interests of Punyashlok Ahilyadevi Holkar PAH Solapur University & ISFT which may come to its knowledge in connection with the performance of this MOU.

ARTICLE IX: RESOLUTION OF DISPUTS.

- a) Any dispute or controversy which cannot be resolved by mutual agreement within 60 days or any claim arising out of or relating to the MoU, or the breach termination invalidity thereof shall be settled by arbitration in accordance with GOI Laws;
- b) Incase of the premature termination of contract due to violence of any terms by ISFT it shall be sole responsibility of ISFT to refund the 80% amount to the student who have taken admission and unable to complete the same due to this situation.
- c) Any dispute & controversy is in subject to under the judicial of Solapur court.


